

INSTRUCTION OF THE PRESIDENT OF THE REPUBLIC OF INDONESIA

NUMBER 6 OF 2007

ON

POLICIES TO ACCELERATE DEVELOPMENT OF THE REAL SECTOR
AND EMPOWER MICRO, SMALL AND MEDIUM ENTERPRISES

PRESIDENT OF THE REPUBLIC OF INDONESIA,

To accelerate the development of the real sector and empower micro, small and medium enterprises so as to increase the growth of the national economy, and as an extension of Presidential Instruction Number 3 of 2006 on the Policy Package for Improvement of the Investment Climate, this instruction is issued:

2. The Minister of Finance;

9. The Minister of Public Works;
10. The Minister of Communication and Information;
11. The Minister of Manpower and Transmigration;
12. The Minister of National Education;
13. The Minister of Culture and Tourism;
14. The State Minister of National Development Planning/Head
of Bappenas;
15. The State Minister of Cooperatives and Small and Medium
Enterprises;
16. The State Minister of State Owned Enterprises;
17. The State Minister of Housing;
18. The State Minister of Culture and Tourism;
19. The Minister for Empowerment of State Apparatus;
20. The Minister State Secretary;

- 21. The Cabinet Secretary;
- 22. The Chairman of the Investment Coordinating Agency;
- 23. The Head of the National Defense Agency;
- 24. All Governors;
- 25. All Regents/Mayors.

- To :
- FIRST : Take necessary measures in accordance with the duties, function and authority of each, in the framework of implementing Policies to Accelerate the Development of the Real Sector and Empower Micro, Small and Medium Enterprises to increase the growth of the Indonesian economy.
- SECOND : In taking measures as meant in the FIRST dictum, to be guided by the program which includes improvement of the investment climate, financial sector reform, accelerating infrastructure development, and empowering micro, small and medium enterprises as stated in the annex to this Presidential Instruction.
- THIRD : a. The Coordinating Minister for Economic Affairs coordinates activities implemented by Ministers/Heads of Non-Departmental Government Agencies.
- b. In the framework of implementing this Presidential Instruction, with respect to programs related to the authority of Bank Indonesia, related Ministers will coordinate with the Governor of Bank Indonesia.
- FOURTH : The Coordinating Minister for Economic Affairs:
- 1. Monitors the implementation of this Presidential Instruction and reports periodically to the President;
 - 2. Establishes a Monitoring Team and determines the duties, organizational structure, membership, working procedures and secretarial affairs of the Monitoring Team.
- FIFTH : Ministers, Heads of Non-Department Government Agencies, Governors and Regents/Mayors monitor implementation of this

Presidential Instruction in accordance with the duties, function and authority of each, and appoint an official in each respective area to assist implementation of the duties of the Monitoring Team as meant in the FOURTH dictum of this Presidential Instruction.

SIXTH : Implement this Presidential Instruction with full responsibility.

This Presidential Instruction comes into force as of the date of its issuance.
